#### LETTER FROM THE CHAIRMAN

This has been a quiet 6 months on the political front as no further progress will be made on White House Farm until the section 106 agreement is signed between the developers (Miller and Linden Homes) and the WSCC. This is now expected by the end of the year. However, the first meeting of the "Reserved Matters Community Liaison Group" has been held, which is a step forward in communication with the developers.

We welcome the West Walls Residents Association, which has been formed to represent the area around West Street, the south end of Orchard Street and Tollhouse Close. We already have members in these areas, but there is no reason why residents cannot be members of both, but we expect to remain the primary representative body for Westgate. The WWRA is particularly concerned about plans to replace the Westgate/West Street/ A286 roundabout with traffic lights. We are aware of this proposal and will watch any changes carefully, but our main concern is the effect on the proposed Southern Access Road to White House Farm on the traffic in Westgate.

The Chichester Road Space Audit (RSA) seems to be gaining momentum and if it is implemented it is going to impact on our lives in Westgate. I strongly urge you to visit the website (Google: Chichester Road Space Audit) to see what it is all about: The executive summary (sections 1.1.1 to1.1.28) is informative and I hope will encourage you to dip further into the document. Pages 77 and 78 (6.2.28 – 6.2.42) refer to the Westgate area, but many of the other changes will alter our environment. # Worried about traffic speeds on Westgate - get involved! Speedwatch volunteers welcome...

WGRA have written before about the challenges of planning the transport options for Westgate given the WHF development, but of course that is some years ahead. In the meantime, we know that traffic volumes and the speed of traffic continue to be issues for Westgate residents. Westgate is a designated 20mph area, with HGV traffic excluded except if delivering, but we know that traffic, particularly through-traffic, tends to ignore this. A 20mph speed limit is not legally enforceable. However, we can as a community take steps to organise our own Speedwatch. Using technology to monitor traffic speeds on the road, we could have a presence on the road that will hopefully deter motorists from speeding, and potentially get the police involved where there are persistent speeding offenders.

Chichester Neighbourhood Policing Team currently loans out its speed calming equipment known as SID's (Speed Indicator Devices) to volunteers to educate drivers of vehicle speeds in the communities. Committee member Julia Smith has volunteered to look into this on behalf of WGRA and to coordinate a group of volunteers trained to borrow the SID equipment for some sessions on Westgate.

Other things residents can do:

- observe the 20mph limit, and drive slowly even if there is a tail of traffic behind you
- always stop for pedestrians, children and make space on the road for cyclists

If you are interested in local community issues around cycling, there are some local initiatives like 20s Plenty, Chi Cycle and other groups that try to work with the County and District Councils.
