COMMITTEE NEWS

Update

As you will all know by now, Richard Brownfield has stood down as Chair of the Westgate Residents Association and we want to thank him for his five years' valiant service on our behalf.

Many of you may not be aware that a residents' association was formed originally to safeguard our street's interests as the new Tesco supermarket rose on the series of interchanges to the south and west of the Sherborne Road junction with Westgate. Some of the former officers still live in our midst, most notably Sue Doggart and Tony Schofield! However, with new issues threatening to disturb our relative peace such as Whitehouse Farm and its many ramifications, Richard; then Secretary Colin Hicks, and their fellow-Committee members breathed new life back into the organization.

We are now in a strong position to continue representing residents in planning debates and also to take on board much of what the Westgate Helpers have done to foster not only community initiatives during the current Covid-19 emergency but also the wider interests of local residents.

In the meantime, Treasurer Vince Waldron and Committee Member Sarah Quail are coordinating WGRA business along with Secretary Bebette Jones until the AGM on 14 November 2020.

The Way Forward

Advised to meet as soon as possible by Richard, the Committee held an Extraordinary Meeting on 21 July 2020. Arrangements were made to send representatives to meetings currently scheduled and, more importantly, it was agreed to bring forward for discussion and, hopefully, agreement at the next scheduled meeting of the Committee on 7 September 2020 plans for a devolved system of governance. Briefly, we are talking about setting up four sub-committees (actually it is three more as the Beaux-Belles exist already). Each would have their own leader who will report to the main Committee. The proposal is for the following sub-committees: Planning and Traffic; Community (Westgate Helpers etc.); Social (Beaux-Belles) and Communications (*Bulletin* and *Newsletter*).

As the Beaux-Belles have proved so successfully, it is possible to recruit willing hands to less formal groupings. Many people just do not have the time or inclination to serve on a formal committee and this is a way of increasing the numbers of interested WGRA volunteer workers - and of spreading the workload.

PLANNING AND TRAFFIC

Whitehouse Farm (WHF) Development Westgate / Orchard Street Roundabout

The Phase I highways works (which include Westgate improvement works) have now been largely agreed. The major outstanding issue is the proposed Westgate/Orchard Street signalised junction to which the WGRA Committee, following the overwhelming result of the Questionnaire in March, is strongly opposed on traffic and environmental grounds. Installation of these traffic lights forms part of the Section 106 Agreement between WSCC and the developers and thus reversing it is no easy matter.

It has been suggested that the traffic lights would provide a safer journey for pedestrians and cyclists than the existing roundabout. West Walls Residents Association are however also strongly opposed and have put forward a compromise proposal. This retains the current roundabout but caters for the interests of pedestrians and cyclists by adding cyclist/pedestrian on demand traffic controls on each of the five roads leading off it. This is considered to be a sensible compromise by the WGRA Committee.

This proposal has been with the developers for consideration for some time. Disappointingly they failed to provide a response at the recent ISG meeting. They have indicated that they expect to respond at the next ISG meeting in September.

WHF Phase II

Discussions are now underway between Councillors and the developers with regard to moving forward with Phase II of the WHF development. Sarah and Gabrielle attended a meeting on this last week with our Councillors and other community groups. Richard Plowman, our Mayor, is very keen to get community input into the masterplan for this phase. It is thought that an outline planning application will be brought forward in about 12 months' time.

Of key importance to Westgate residents will be the routing of the Southern Access Road linking the development with the A27 Chichester bypass. No specific proposal for this is publicly available yet. It appears however from plans prepared by the developers for other elements of the development that they will be seeking to route this along the westernmost part of Westgate to the Westgate/Sherbourne Road mini roundabout. Clearly this would have major implications for traffic/pollution levels all along Westgate as well as having a detrimental impact on the character of our residential area.

We stated our strong opposition to these plans and expressed our strong desire to see lower traffic levels along the whole length of Westgate. The implications of the various alternatives for the Southern Access Road will need to be worked through as the developer's proposals become clearer. We will of course keep residents informed and discuss with you the best way forward.

On a more positive note Richard Plowman asked for suggestions as to any community uses we would wish to see included in Phase II. He suggested a new crematorium and old people's home! Can we suggest any amenities which would benefit younger people?

We will report in the next bulletin on the proposed upgrading of the Chichester to Emsworth cycle route the final section of which runs along Westgate.

Interesting facts:- in Wales the First Minister has set up a task group to implement a 20mph national default for residential roads while in February 2020 global ministers mandated 20mph speed limits wherever cyclists or pedestrians mix with motor vehicles.
