## **COMMITTEE NEWS**

#### Update from the Acting Chair – Sarah Quail

First of all, I need to tell you that, at their meeting on 7 September, the WGRA committee appointed me as Acting Chair to take Richard Brownfield's place until the AGM on 14 November 2020. Richard devoted an enormous amount of time and energy to WGRA work and we are indebted to him for his labour on our behalf. I shall thank him formally at the Annual General Meeting (AGM), of which there is more below.

#### **Governance changes**

The committee also agreed to set up four sub-groups to manage current business. Under the committee's aegis, and as reported in the last Bulletin, those sub-groups will be Planning and Traffic, Community, Beaux-Belles (Social) and Communications. There were two main reasons why we have introduced subgroups. Firstly, we want to better develop the way we manage our business and, more importantly, we want to encourage more of you to participate in the life of WGRA, particularly those of you who do not have the time or inclination to stand for the committee. It is vital that we secure more active members as the pressures on our community are increasing: White House Farm Phases 1 and 2 including not only where the Southern Access Road is likely to be aligned but also - now - the proposed relocation of Bishop Luffa School to a site on the other side of Centurion Way and what this might mean for our street; other traffic issues including the hardy perennial of speeding vehicles; Westgate/Orchard St roundabout planning; ChEm Route and its implications for both cyclists and pedestrians and, of course, resurgent Covid-19 issues.

The Beaux-Belles 'Model', or rather the way in which they operate, is what has inspired thinking. Membership of the Beaux-Belles is informal and easy-going. Likely new recruits are encouraged to come along to meetings – usually at the Crate and Apple! Good friendships have been forged, and we have all been the beneficiaries of the group's efforts at Christmas gatherings, street parties and other social events. This was clearly a model capable of development: a good way to broaden the active membership and to share out the workload more equitably. These ideas coalesced into the recommendations which were approved by the committee at their recent meeting. Do get involved if you are interested in one or more of the above groups.



## ANNUAL GENERAL MEETING

#### Format

You will not be surprised to learn that due to Government restrictions on numbers of people who can meet together, we cannot hold our AGM this year at St Wilfrid's Church Hall. The committee discussed at length the options available and has decided to hold a hybrid meeting. This will be a 'behind closed doors' meeting of the current WGRA committee to conduct the business of the AGM. The legal profession is advising large numbers of different organisations to use this format in the current emergency. However, we propose to open up this meeting to the WGRA membership via Zoom as we feel that this provides some semblance of a democratic process.

You are most welcome to observe the proceedings remotely but voting will be done by proxy in advance of the meeting. This involves members completing a proxy form appointing the Chair of the meeting to vote on their behalf on each resolution to be proposed at the meeting.

We thank you for your understanding and hope that members will participate as much as possible in the new format.

**Nominations** - Officers and committee members are elected at the AGM for one year, at the end of which they all retire, but are eligible for re-election for a further year. #### What happens next?

At the beginning of November, you will receive, by email, your invitation to join the Zoom meeting along with all your AGM papers (Agenda, Annual Report, Financial Report etc.) You will also receive a proxy form for voting on proposals and nominations for officers and committee. This form will also include an opportunity to submit a written question to the meeting which will be dealt with under 'Any Other Business (AOB)'. Please return this proxy form to the Secretary by the date given on the form.

For practical reasons, voting can take place only on the proxy forms in advance and not on Zoom. Only 2019-20 paid-up members are entitled to vote and there is only one vote per household. A full report on the AGM will appear in the next *Bulletin*.
