

3. Additional pedestrian and cyclist crossings added to the current roundabout.

To make this work for cyclists, footpaths around the junction are converted into shared use footways/cycleways.

Unfortunately, we do not consider this to be a viable option given the potential for conflict between cyclists and pedestrians on these shared pathways particularly at the dangerous south -west corner outside No 1 Westgate.



4. A Dutch style roundabout

Zebra crossings for pedestrians are added to all approach roads to the roundabout and a segregated cycle path around the outside. This operates on the principle that drivers give way to pedestrians and cyclists on entering and exiting the roundabout. Although the central roundabout would be smaller the existing tree would be retained if possible and low-level landscaping would be maintained.

The WGRA Committee strongly support this option as the best way of avoiding a fully signalised junction here and retaining a roundabout with improved safety for cyclists and pedestrians. The proposal received unanimous support at the ISG meeting. Traffic modelling is to be undertaken to ensure that adequate traffic flows can be maintained and a sign-off is required from the developers that they are happy to proceed with this option.

Phase II Whitehouse Farm - Bishop Luffa School

We have been informed that the developers are in discussion with Bishop Luffa School about a possible landswop. Under this arrangement the developer would acquire the existing Bishop Luffa site and the school would be relocated into new premises to be constructed by the developer on a site further west. The existing school site would be redeveloped with around 300 low cost residential units.

Whilst a new school is to be welcomed this proposal would have a significant effect on the western end of Westgate given the loss of green space and the impact of the additional housing. We have flagged with our councillors that this will be of significant concern to Westgate residents and again please send any comments to <u>planning.wgra@gmail.com</u>
