Southern Access Road (SAR) Miller Vistry's proposals for the SAR will be debated with the rest of their proposals for White House Farm (WHF) Phase 2 at the meeting of Chichester District Council's (CDC) Planning Committee next week, on Wednesday 10 January 2024 at 9.30 am. Temporary closure of Westgate from 8th to 12th January 2024 Another reminder that Westgate will be



temporarily closed to through traffic for a 15metre section between the junction with Parklands Road and the Westgate/Sherborne Road roundabout. The closure will commence on 8th January and is estimated to be completed on 12th January and is required for the safety of the public and workforce during the disconnection of a gas service. The restriction will be in place 24hrs/day and signs for an alternative route will be in place. Access will be maintained for residents and pedestrians.

Chichester City Arts Centre You may be aware that the Centre requested planning permission to fell a number of trees in the churchyard area in front of the former St. Bartholomew's Church. The owners of the Centre have asked me to include a letter from them in the Bulletin which is copied below. We look forward to the new planting.

"Dear All,

As you are aware, our Tree Works Application at Chichester City Arts Centre has been approved. We are required to plant 5 new small trees or shrubs to offset the removal of the overgrown trees. We would be grateful for any suggestions for new trees or shrubs. They would need to be compact, easily maintained and enhance the gardens.

We have worked hard and self-funded the purchase and renovation of this beautiful but previously neglected building. It is now a usable and welcoming space for everyone to enjoy. This has improved the general amenity of the area by stopping the anti-social behaviour and vandalism that had occurred (although we still get rubbish thrown over the boundary walls, mainly bottles, cans and vaping paraphernalia!).

We already have two squirrels and a fox which frequents the gardens. To encourage more wildlife in the gardens, we would be happy for the local residents to supply and put up bird boxes, bat boxes or any other suggestions to attract wildlife.

In the front garden we have made a new border along the west boundary wall. If anyone has any spare bulbs or cuttings, they would be gratefully received.
